



CSX index edges up slightly Today, the CSX index edged up 0.04% to 351.9 pts, as PPWSA shares gained 0.25%. This morning 12,099 shares changed hands. *(Source: YSC Research)*

PPWSA shares close week down 0.5% Shares in Phnom Penh Water Supply Authority (PPWSA) closed at KHR4,000, down 0.5% from last Friday. With 8,200 shares changing hands today, the volume trading this week came to 16,660 shares. Based on the last close and 2016 earnings, the stock is trading at a P/E of 6.89x.

GTI shares post weekly gain of 4.65% Shares in Grand Twins International (GTI) posted a weekly gain of 4.65%, ending the week at KHR4,500. Only 100 shares changed hands this week.

PPAP shares finish at KHR5,200 for another day Shares in Phnom Penh Autonomous Port finished at KHR5,200 for another day. Based on today's close and 2016 earnings, the stock is trading at a P/E of 6.49x.

PPSP shares end at KHR2,750 Shares in Phnom Penh SEZ Plc (PPSP) ended at KHR2,750, 0.36% lower than last Friday. This week saw 4,909 shares change hands. (*Source: YSC Research*)

Spean Luy launches online platform for loans comparison Local start-up Spean Luy recently launched its web-based loans comparison platform allowing potential borrowers to find various loan options from some of Cambodia's biggest microfinance institutions. The site's founder, Japanese-born Yuta Nagano, said his goal is to create "Financial Inclusion 2.0", where people have a wide range of financial products to choose from to improve their quality of life and can benefit from lower interest rates. Currently, the platform only lists information on loans, but Nagano expects to secure between four and six official partnerships with financial institutions in the next two months, allowing users to apply directly for loans on the Spean Luy website. He also plans to increase the number of MFIs tracked by the site, and eventually add banks. Organizations seeking to improve financial literacy and encourage responsible lending practices say a platform like Spean Luy could be particularly useful in Cambodia, where the banking sector is characterized by low financial literacy, a dizzying number of microfinance institutions and notoriously high interest rates. 


